# KEVIN PROCH MEMORIAL 3v3 BASKETBALL TOURNAMENT



#### I. Player Eligibility:

- a. All player ages must be 19 years old or older
- **b.** Players can only appear on one (1) roster. Any player appearing on more than one roster will be disqualified.
- **c.** Players are required to bring a form of identification to verify information provided on the original registration form. Inaccurate information provided on the registration form will result in player disqualification.
- **d.** Additions and/or changes on roster will not be permitted after the beginning of the tournament.

## II. Scheduling:

- a. Teams will receive schedules 2-3 days prior to the tournament. If schedules aren't received email <u>alexd@northtonawanda.org</u> or text 716-579-4434
- **b.** Teams will have 5 minutes to warm-up prior to their game. Teams that are not present at game time will forfeit the game. No exceptions.

#### III. Scoring:

- a. A field goal is worth 1 point
- b. A successful basket made from behind the designated line is worth 2 points
- c. Games are 15 points, win by 2 (up to a maximum of 20 points).
- **d.** All games have a 20 minute time limit. Time will be kept by the referee and/or scorekeeper.
- e. The team leading the game at the end of the 20 minute time limit will be declared the winner.
- f. If a game is tied at the end of the time limit a coin will be flipped for possession and the first team to score will be declared the winner.

#### **IV. Fouls & Violations**

- a. The referee will call all fouls and violations.
- **b.** Teams are allowed 6 fouls per contest. Fouls 1-6 will result in a dead ball with the opposing team gaining possession. No free throws will be awarded (even if the foul occurred in the act of shooting).
- **c.** <u>Shooting fouls</u> will be handled in the following manner (on and after the 7<sup>th</sup> team foul)
  - <u>A made basket</u>: Count the basket and whether the ensuing free throw is made or missed, possession will go to the defensive team.

Missed basket: If the free throw is missed the offensive team retains possession

If the free throw is made, possession goes to defensive team

Note: One free throw will be awarded for all shots, including shots attempted from behind the 2 point line.

- **d.** <u>Non-Shooting fouls</u> will be handled in the following manner (on and after the 7<sup>th</sup> team foul)
  - If the free throw is made possession goes to the defensive team.
  - If the free throw is missed the offensive team retains possession.
- e. All technical fouls will be counted as a team foul
- **f.** Technical fouls will be called in the event of:
  - i. Any misconduct, flagrant or intentional fouls committed by a player.
  - ii. Vulgar or abusive behavior
  - iii. All other misconduct deemed inappropriate by the referee.
- **g.** Technical fouls will result in two free throws and possession awarded to the opposing team.
- h. Two or more technical fouls will result in player disqualification from remainder of the games.

#### V. Liability/Waiver Forms

- a. All players must sign the waiver form prior to playing in the tournament.
- b. Players under the age of 18 years old are required to have a parent or guardian sign the waiver form.

### Over the Age of 18 years old

I the undersigned player, acknowledge, agree and understand that:

- 1. Voluntarily and of my own free will, I elect to participate in this basketball tournament.
- 2. I understand that basketball entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activity. In an effort to minimize those risks, I agree to wear protective wear if needed when involved in basketball.
- 3. I expressly agree and promise to accept and assume all risks associated with this activity. My participating in this activity is purely voluntary and I elect to participate in spite of these risks.
- 4. I herby voluntarily release, forever discharge, and agree to indemnify and hold harmless The City, from any and all claims, demands, or causes or action which are in any way associated with this activity or my use of City equipment or facilities, including any such claims which allege negligent acts or omissions of The City.
- 5. Should The City, or anyone acting on their behalf be required to incur attorney's fees and cost to enforce this agreement, I agree to indemnify and hold harmless The City or any such person from all such fees and costs.
- 6. I herby state that I will bear the cost of any injury or damage that I may cause or suffer while participating. I further certify that I have no medical or physical conditions which would or could interfere with my safety in this activity or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly by such condition.

By signing this document, I acknowledge that if anyone is hurt, or property is damaged during my participation in this activity a court of law may find me to have waived my right to maintain a lawsuit against The City, on the basis of any such claim or claims form which I have released them herein. I acknowledge that I have read and understand each and every one of the provisions above in this waiver, and agree to abide by them.
